UPDATE ON ADMISSION PRACTICES

SIGNIFICANT CHANGES IN THE CODE OF ETHICS AND PROFESSIONAL PRACTICES

Background:

Shortly after the 2017 National Association of College Admissions Counseling National Conference concluded, the Department of Justice Anti-trust Division, launched an investigation into the approved NACAC Code of Ethics and Professional Practices (CEPP) with respect to an anti-trust complaint focusing on certain provisions in the document which allegedly had the potential of restricting trade. The charge and subsequent investigation centered on three provisions in the CEPP document:

- 1. Incentivizing Early Decision
- 2. Transfer recruitment of enrolled students
- 3. "Poaching" enrolled students after May 1

Over the last two years, NACAC leadership along with NACAC legal-counsel navigated through the investigation and subsequent findings by the DOJ – AT Division. In February of 2019, NACAC legal-counsel strongly advised leadership to reach an agreement with the Department, in order to bring an end to the legal pursuit and avoid further financial drain on the organization. In July 2019, the Presidential Council of NACAC agreed to follow the NACAC Board direction and take the necessary to steps to remove the problematic provisions. At the recent NACAC National Conference in Louisville, membership voted to remove the offending provisions from CEPP.

Implications for WACAC members:

College Admissions: We believe many admissions offices are still trying to figure out implications/ opportunities on their end.

High School Counseling:

- 1. Aggressive and earlier marketing to students
- 2. Incentivized early application plans
- 3. Continuation of marketing to students after May 1
- 4. Incentivizing enrolled students to transfer from one college to another
- 5. Increased need for teacher recommendations to be completed by the summer before senior year
- 6. Increasing majority of students having applications out-the-door early in the senior year
- 7. Enrollment deposit amounts significantly increasing in an attempt to hold the class curb summer melt
- 8. An increase of breaking and/or ignoring ED agreements once it becomes financially preferable to do so

Future of Admission Practices Committee:

Clearly, these changes in our profession's mandated ethical practices warrant an evolution in the role of our association's admission practices committee. Over the next few months our board and membership will be in conversation deciding on that new direction. Regardless, it is safe to assume that the investigation and enforcement role of the committee with respect to ethical compliance has probably ended. That said, our other responsibility; that of educating membership on best ethical practices will minimally continue.
